As such, and fully understanding this, I/we have agreed, I/we shall not in any way, hold **Brittany's Hope** responsible or liable for any claims or demands or injury for any losses or liabilities resulting from this placement and further agree that I/we shall defend, indemnify and hold **Brittany's Hope** harmless from and against all damages, losses, liabilities and claims against them caused or arising out of the placement of this child(ren) through the independent Agency from whom I/we receive said child(ren).

### *Agreement to Raise Supporting Funds*

1. Grant Recipient will endeavor to raise a minimum of donations to **Brittany's Hope** equal to one-half (1/2) of the *Adoption Grant* awarded. A minimum of \$\_\_\_\_\_.

3. Grant Recipient understands and agrees that should they not raise the commitment of one-half (1/2) \$\_\_\_\_\_ of the *Adoption Grant* amount of \$\_\_\_\_\_, they will receive funds equal only to the amount they raised and not the full grant amount awarded.
  - a. **Brittany's Hope** will not be liable for the difference between the amount raised and the awarded *Adoption Grant*.
4. I/We understand and agree that any funds raised may be used by **Brittany's Hope** toward other *adoption grants*.
5. Grant Recipient understands that the grant check will be paid directly to my/our *Adoption Agency* to be used toward legitimate adoption expenses upon receipt of the following:
  - a. All pre-adoption grant documents
  - b. Grant fundraising efforts have been fulfilled
6. Grant Recipient understands I/we may not donate money to **Brittany's Hope** toward my/our own adoption expenses.
7. Grant Recipient understands that should they fail to raise one-half (1/2) of their *Adoption Grant* amount prior to travel to bring home their child(ren), they must submit a one-time grant extension request or their grant will be forfeited.
